2. All instructions of the Minister or persons acting on his/her behalf are complied with.
3. The applicant shall make good, or pay the cost of making good, any damage to property arising out of the use of this permit.
4. No structure, or installation, may be constructed or installed without the written permission of Wicklow Mountains National Park.
5. This permit does not give exclusive use of the site (*Wicklow Mountains National Park is used by other groups, licensees and right-holders*).

6. The permit holder will ensure that all of their agents and assigns are informed that they are in a National Park and must ensure that they do not leave litter. (*Litter includes biodegradable waste*).

7. The Duty Ranger at Wicklow Mountains National Park is contacted at **087 980 3899** in the case of any notable incidents occurring during the event, e.g. accidents, etc

8. Wicklow Mountains National Park is acknowledged in any public communication resulting from your activities in the National Park.

9. Additional special conditions:

- a. Pilots are expected to have their own insurance and to ensure the serviceability of their equipment.
- b. The IHPA is expected to have a competency standard for their Pilots and an accident an emergency plan to deal with any unexpected events that may arise.
- c. A pilot will phone the Duty Ranger on **087 9803899** (weekends only) or **0761002667** weekdays prior to each flight to inform them of their intended flight in the Wicklow Mountains National Park. (Voice message is acceptable, no text messages please). Notification of this call will be circulated amongst other pilots through the IHPA "Whatsapp group" to reduce multiple calls.
- d. Pilots will report to WMNP any accident or notable incident which takes place during a flight, as soon as is reasonably practicable after completion of the flight.
- e. ***Pilots are requested to avoid the sensitive sites of Lough Bray Lower and Maulin/Raven's Glen during the Peregrine Falcon nesting season of March 1st – July 31st*(see below)***
- f. Training flights are permitted on the gently sloping ground North of Lough Bray Lower – sloping eastwards, on condition that these run out to the East and under no circumstance fly into the bowl of Lough Bray Lower. Training flights should be logged in advance by emailing: wmnp@housing.gov.ie at least 2 days prior.
- g. A list of registered members to be supplied to WMNP after the date of Annual renewal in April. Membership cards should be available for inspection should the need arise.


- Request that areas are not overflown for specific periods of time

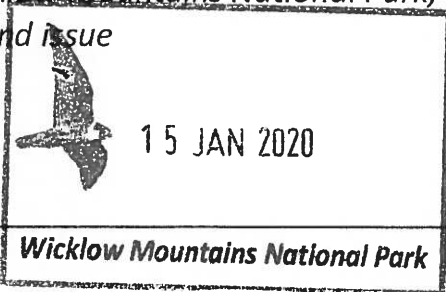
